Thank you for your message. I have revised my article to state the following:

Although the names of the individuals behind the APMP are not on the website or Facebook page, my impression was then, and still is now, that the APMP is essentially Allison Black Cornelius (who is the CEO of GBHS), an attorney named Angie Hubbard Ingram and members of a rescue group which was up until recently called Cavalier Rescue of Alabama (and now operates as The Cavalier Rescue). We have not changed our name. We simply added a dba name, which is a very common thing to do. Given our nationwide network and relationships across many states with other rescues, shelters, and veterinarians, this makes things much less confusing as we communicate on a day-to-day basis.

We were not "outed" by WaPo. For you to state such implies we are doing something illegal or immoral. We are not. We routinely share our auction activities (#auctiondogs) and have never attempted to hide this, or mislead anyone. That article was inaccurate and misled others to think we spent a lot of money which was actually spent by others, and that we spent the most most on two Cavaliers (those two \$12,500 dogs were was actually purchased by another Cavalier Rescue, commonly referred to as the "Rescue Trust"). In fact, The Cavalier Rescue organization don't even exist at the time of that event.

We are quite used to people like you spinning information to negatively affect our organization and efforts. It's a real shame someone in your line of work fails to do their research before penning such inaccuracies with a negative intent.

I would appreciate it, if you would update your article to be more factual with regard to the information started about Cavalier Rescue of Alabama dba The Cavalier Rescue.
